FTC: BlueHippo business model is “Built on Deceit”

Last week, the Federal Trade Commission asked a federal court to [issue a contempt order](#) against Maryland-based BlueHippo Funding, LLC for violating a court ordered settlement issued in April 2008. BBB serving Central, Coastal and Southwest Texas first alerted consumers to this computer dealer in a [press release](#) on May 8, 2009. Since then, 12 additional consumers in the local area have filed complaints against BlueHippo.

In a [statement released by the FTC](#), Chairman Joe Leibowitz stated, “We’re putting companies like this on notice: If you mistreat consumers and thumb your nose at the courts, we will hold you accountable.”

BlueHippo claims to provide an alternative for people with limited financing options, such as poor or no credit, to own expensive items like computers. Consumers across the country complain the company does not deliver merchandise on time, does not provide a contract, denies refunds and makes unauthorized withdrawals to their bank accounts.

“According to BBB records, Blue

Hippo has targeted a vulnerable group of consumers with poor credit and taken advantage of them,” said Carrie A. Hurt, President and CEO of BBB serving Central, Coastal and Southwest Texas. “BBB supports the Federal Trade Commission’s efforts to stop BlueHippo and hold them accountable.”

In the past 36 months, BBB has received 4,145 complaints about BlueHippo, and the company has failed to respond to any complaint filed since February 2009. Click [here](#) to view BlueHippo’s current BBB Reliability Report™.

The company has a BBB rating of F due to failure to comply with an arbitration decision or mediation settlement, failure to respond to 2,516 complaints, the company’s overall complaint history and past government action taken by The Attorneys General in Maryland, West Virginia and Illinois.

Consumers like Kim Becerra of San Antonio continue to be out substantial amounts of money.

“I still don’t have a computer,” said Becerra. “I filed a complaint with my bank to get my money back, but BlueHippo denied the refund.”

BBB offers the following tips when ordering items by phone or online:

- ◆ · **Protect your private information.** When shopping online, look for the retailer’s Web site privacy policy and never provide your Social Security number, birth date, or mother’s maiden name.
- ◆ · **Don’t wait for paper statements.** Check your credit card and bank statements for suspicious activity by calling your bank or visiting your financial institution’s Web site.
- ◆ · **Check the company’s refund policies.** Some merchants set a deadline for returns or charge a fee to accept returned merchandise.
- ◆ · **Pay with a credit or debit card.** For extra protection enroll your card in anti-fraud programs.

USDA gets \$35 million for distance learning

Agriculture Secretary Tom Vilsack announced that 111 projects in 35 states have been selected to receive more than \$34.9 million in grants that will increase educational opportunities and access to health care services in rural areas. The funding will be provided through USDA Rural Development’s Distance Learning and Telemedicine Program. Five projects in Texas have been selected to receive \$1,443,395.

“The Obama Administration is working to ensure that rural citizens have access to a full range of educational opportunities and access to quality medical care,” Vilsack said. “The funding we are announcing today will deliver these opportunities by expanding telecommunications, educational resources and computer networks throughout rural communities.”

The Distance Learning and Telemedicine (DLT) Grant Program provides access to education, training and health care resources in rural areas. Funding is

contingent upon the recipient meeting the conditions of the grant agreement. These funds are part of USDA’s annual budget and are not part of the American Recovery and Reinvestment Act.

“Schools and health care providers in rural Texas have increasingly tighter budgets. Grants such as these are powerful tools for providing expanded edu-

cational and health care opportunities which otherwise may be unavailable,” Paco Valentin, USDA Rural Development State Director of Texas said

Coastal Bend College will receive \$193,786 to enable their Distance Learning and Allied Health Training Project to high schools located in Benavides, Karnes City, Pettus, Skidmore and Woodsboro.

City breaks ground on \$2.8 million project

Alice residents will soon see an upgrade in their water systems with the replacements of water main lines.

With the coined motto "Alice Moving Forward" Alice City Mayor Dr. Rito Silva spoke about the improvements of the city during a ground breaking ceremony at the Homer Dean Jr. Water Treatment Plant. Mayor Silva praised both the present and past city councils for their dedication to laying the groundwork for improvements.

"It's a great time to be on the council," he said. "We have to thank both the present but those who came before us and laid the groundwork to pass the bonds."

Funding for the \$2.8 million Waterline Upgrade project was approved during the 2007 \$9.6 million bond election. The Texas Boulevard project is all ready underway with some of the behind the scene workings being done at the plant.

State Representative Yvonne Gonzalez-Toureilles also spoke at the ceremony as she recognized the efforts being made by the city.

"Infrastructure improvements such as this is an investment in our community," she said. "This particular one will help improve the quality of life for families in Alice."

Alice City Manager Ray De Los Santos Jr. reminded residents to be patient when it comes to the work being done on Texas Blvd.



On hand for the ceremony were Jim Wells County Commissioner Ventura Garcia, Justice of the Peace Juan Rodriguez, William Findley, Councilwoman Yvette Johnson, State Representative Yvonne Gonzalez-Toureilles, Alice Mayor Dr. Rito Silva Jr., City Engineer Monty Winter and Alice City Manager Ray De Los Santos Jr.

"We will see some traffic and we ask everyone to be patient as work begins as well as when we have to cross 44 and the railroads," De Los Santos said. "It will just take a little patience from everyone

in the community to cooperate while the project is going on."

Estimated completion of the project is December 2010.

Congressional Democrats introduce dropout legislation

U.S. Rep. Rubén Hinojosa (TX-15) along with other Democratic Members of Congress on the Education and Labor Committee, introduced critical legislation to address the high school dropout crisis. Nationwide, about 7,000 high school students drop out every day. Only about 70 percent of students, across the nation, now graduate from high school with a regular diploma.

This legislation creates a new \$2 Billion competitive grant program to improve the nation's lowest performing high schools and middle schools.

"Our nation's "dropout factories" pose one of the greatest threats to our nation's growth and competitiveness. "The Graduation for All Act of 2009" builds on "The Graduation Promise Act" to address the high school dropout crisis by investing in our nation's lowest performing middle and high schools", said Hinojosa.

This legislation would provide school districts clear guidelines on turn around strategies. It will combine rigorous coursework with academic and social support services to encourage students and keep them engaged in school. It will also help schools implement a data system to allow teachers and other school staff to identify students who are at risk
